ITEM 3 - CHAIRPERSON'S REPORT

In the absence of the Chair of Academic Board, who was overseas on university business, the Acting Chair, Prof Jon Buckley, presented Prof Deirdre Tedmanson's report. He reported that since the previous Board meeting in March 2025, Prof Tedmanson had attended the May UniSA Council meeting at which there was a presentation from the Adelaide University Deputy Vice Chancellor (International and External Engagement), Prof Jessica Gallagher, as well as a number of reports on transitional arrangements, including budgetary and risk assessments, Governance and Nominations Committee reports leading to the foreshadowing of a number of honorary awards. Prof Tedmanson had also attended the June UniSA Council meeting at which there were presentations regarding the Research and Enterprise Portfolio from UniSA Deputy Vice Chancellor (Research and Enterprise), Prof Peter Murphy, the University of South

Australia Student Association (USASA), as well as reports on transitional arrangements and governance matters, and Audit and Risk reports. The April and May meetings of the Adelaide University Transition Council were strongly preoccupied with transition matters, and particularly the appointment of the new Vice Chancellor. The Adelaide University Transitional Academic Board, of which Prof Tedmanson was co-chair, had also met in March, May and June with the focus on progressing academic program, course, and research transition to Adelaide University. In addition, along with the co-chair of the Transitional Academic Board she had met with Independent Advisor, Emeritus Professor Ian O'Connor, on Academic Board matters.

ITEM 4 - VICE CHANCELLOR'S REPORT

- The Provost and Standing Acting Vice Chancellor, Distinguished Professor Marnie Hughes-Warrington AO, introduced the Vice Chancellor's report, which was taken as read, by drawing member's attention to the following matters:
 - 6.1 The Adelaide University Transition Council had announced the appointment of Prof Nicola Phillips as the new Adelaide University Vice Chancellor to take up office on 12 January 2026 and lead the new university through its formative years. Prof Phillips brought a depth of knowledge with 30 years of experience in the higher education sector across Australia and the United Kingdom. She was currently the Provost and had served as Acting and Interim Vice Chancelor of the University of Melbourne.
 - 6.2 Quacquarelli Symonds (QS) had released its World University Rankings by Subject for 2025. Rankings were compiled using five key indicators: academic reputation; employer reputation; citations per paper; h-index; and international research network (by broad faculty area). This would be the last time UniSA would be ranked as a university, with the QS Subjects Ranking 2026 providing a ranking for the new Adelaide University. UniSA was ranked in the top 100 in the World in two subjects: Nursing and Sports related subjects. UniSA was ranked in the top 10 in Australia in two subjects: Architecture and Built Environment and Hospitality and Leisure Management. UniSA ranked number one in South Australia for: Architecture and Built Environment, Sports and related subjects, and Hospitality and Leisure Management. UniSA ranked in the top 100 in the World for citations in eight subject areas: Nursing (ranked 6th), Hospitality and Leisure Management (ranked 6th), Sports and related subjects (ranked 28th), Education (ranked 42nd), Law (ranked 42nd), Arts and Humanities (ranked equal 55th), Accounting and Finance (ranked 58th), and Social Sciences and Management (ranked 82nd).
 - UniSA's Australian Research Council (ARC) Linkage Grant performance was excellent with four successful research projects winning more than \$2.4 million in funding. Prof Martin Shanahan had won \$903,456 with Dr John Wilson and University of Adelaide colleague Dr Florina Ploecki, in collaboration with colleagues from two other universities, and four community groups, for a project to digitise over three million public records. The records would be used to compare life-course outcomes for two generations of 19th century Tasmanians and South Australians, examining intergenerational mobility and inequality. Dr Zehong Cao had won \$643,052 for a project aiming to develop AI-enabled collaborative autonomy for complex spacecraft systems. Prof Jun Ma had won \$300,420 for a project which would develop strong,

sustainable rubber materials replacing fossil-based filters with plant-derived cellulose nanofibers. Assoc Prof Thong Pham had won \$584,833 for a project aiming to develop an advanced form of 'green concrete' by combining calcined halloysite clay with recycled plastic fibres, all optimised using artificial intelligence. GO8 analysis on the back of the Linkage outcomes which combined UniSA and University of Adelaide outcomes placed the new Adelaide University 4th nationally in ARC Linkage Grant performance.

UniSA's National Reconciliation Week (NRW) program across metropolitan, regional campuses and hubs from 27 May to 3 June had been the most successful ever held. A dedicated group of university staff and students worked together to create the program with a variety of free in-person and online meaningful events, including *Nunga* screening 2025, around the theme of *Bridging Now to Next*, which reflected the ongoing connection between past, present and future calling on all Australians to step forward together, to look ahead and continue to push forward with past lessons as a guide. Special acknowledgement went to the NRW Steering Group and Working Groups, with particular to the co-chairs Anna Schkabaryn, Manager: Wirringka Services, and Chris Crabbe, Manager: Student Life from the Student Engagement Unit for their leadership.

- The Deputy Vice Chancellor (Research and Enterprise), Prof Peter Murphy, provided an update on the progress of strategies to maximise the benefits of participation in the Commonwealth Government's Cooperative Research Centres (CRC) Program, which was a very real vehicle for industry engagement. He reported that UniSA had completed its CRC Strategy, with all items now finalised, and summarised progress against the plan over previous years and key outcomes, in addition to recommendations to guide the transition to the new university structure. Between 2019 and 2023 UniSA had been involved in 143 CRC projects. UniSA was ranked 8th nationally for CRC income (HERDC Category 4) and following the establishment of the new Adelaide University in 2026 we would be ranked 1st in the nation for CRC engagement.
- UniSA was working closely with the University of Adelaide CRC Committee to align with the Adelaide University research strategy. To enable a more strategic approach moving toward the new university, the UniSA CRC Advisory Committee would continue attending joint meetings throughout 2025 with the expectation that an Adelaide University Advisory Committee would be formed commencing in January 2026. Proposed considerations moving forward included: joint review of new and existing CRC opportunities; identifying potential synergies between bids; strategically assessing future bid prospects; establishing a joint decision-making governance mechanism; adopting a shared communication and bid-filing strategy; implementing a joint Notice of Intent and Business Case template; implementing current internal CRC processes; and engaging Business Development Managers.

ITEM 7 – FOR INFORMATION

7.1 HIGHER EDUCATION POLICY UPDATE

The Provost and Standing Acting Vice Chancellor, Distinguished Professor Marnie Hughes-Warrington AO, provided an update on some higher education policy issues. She reported that the Prime Minister had announced the new Cabinet on 12 May, retaining Richard Marles as Deputy Prime Minister and Minister for Defence, Penny Wong as Foreign Minister, Jim

Chalmers as Treasurer, and Jason Clare as Education Minister, for an unchanged senior ministry. The full suite of education elections announcements included plans to reduce HELP debt by 20% for 3 million students with loans, and the intention to formally establish the Australian Tertiary Education Commission (ATEC). The United States (US) Trump administration had cut or paused funding to seven Australian universities, which potentially put \$600 million in joint research efforts at risk. The US was the biggest overseas funder of research in Australia, with 25% of Australia's publications in biomedical and clinical sciences involving US collaborators. The institutions affected were the Australian National University, Monash University, the University of Technology Sydney, the University of New South Wales, Charles Darwin University, Macquarie University, and the University of Western Australia.
