## Notice of Preclusion

As we have communicated previously, we monitor academic progress regularly via the Academic Review process to help you succeed in your program.

For 1st Review Period 2022, you have been identified as making unsatisfactory progress in the program [Program Name] due to:

- Failed 50% of your courses in this review period *and*
- Failed a course(s) for a second time *and*
- Failed a practicum or clinical placement

## How does this impact my studies?

As you have failed to progress in your studies for three or more review periods, **you will now be precluded from further study.**

Preclusion means that:

- your enrolment in your program will be discontinued
- you will be prevented from studying in this program, or a program in the same discipline, for the next two years
- application for re-admission will follow normal procedures and is not guaranteed

**Please be aware that:**

- as a condition of your student visa, you are required to maintain satisfactory academic progress and attendance. This means you must continue your studies while your appeal is being considered.
- the University is obliged to maintain your Confirmation of Enrolment (CoE) while the appeal is ongoing.
- preclusion from your program constitutes a breach of your student visa. If you are precluded, the University is required by law to notify the Department of Home Affairs. This results in cancellation of your CoE and may result in the cancellation of your student visa.

## What do I do next?

### Appeal

If you feel you have grounds to appeal the decision to preclude you from your

program, you may appeal by completing an Appeal to the Preclusion Appeals Committee application and attaching supporting documentation.

From Friday 15 August 2022, any courses you are currently enrolled in will be dropped and you will be withdrawn from your program.

## Important information

- If you have grounds to appeal, you have 20 working days to lodge your appeal. You must lodge your appeal no later than close of business **Friday 15 August 2022**.
- You may continue your studies while your appeal is being considered.
- If your appeal is unsuccessful, or you choose not to appeal within this timeframe, you will be precluded.
