About Germany and Oestrich-Winkel

Germany is a Western European country with a terrain of vast forests, rivers and mountain ranges, and 2 millennia of history.

Oestrich-Winkel is part of the Rheingau wine region, settled alongside the Rhine and is the largest wine growing town in the state of Hesse. Oestrich-Winkel is around a 1.5 hour train ride from Frankfurt airport.

SUMMER SCHOOL - SUCCESSFUL LEADERSHIP IN EUROPE

EBS offers an MBA Summer MBA Session in May each year. The three week program "Successful Leadership in Europe" is divided into three parts: Lectures and Case Studies, Corporate Visits and Social Activities. Valued at 10 ECTS, the course is ideally suited to

MBA students however Specialist Masters students may also apply. A service fee of \$500 applies and travel and living expenses are not included.

What does it cost?

As an exchange partner with the University of South Australia, you do not have to pay tuition fees to EBS Business School as these are included as part of your fees at UniSA.

Travel and living expenses are at your own cost. The table below gives an indication of costs you will incur:

ITEM	COST
Return flights - Adelaide to Frankfurt	\$2200
Train from Frankfurt Airport to Oestrich-Winkel	\$40
Regional transport (not optional)	\$170 per semester
Accommodation	\$650 per month
Health insurance	\$115 per month
Meals	\$360 per month
Textbooks and materials	\$70 per course
Entertainment and incidentals including phone, laundry etc.	\$400 - \$600 per month

Key dates

- Fall Semester: August - December which corresponds with UniSA Study Period 5. The closing date for applications is January 11.
- Spring Semester: January - May which corresponds with UniSA Study Period 2. The closing date for applications is August 1.

All exchanges are managed by the study overseas team at UniSA International who will help you apply for your exchange and will contact the partner institution on your behalf.

Entry requirements

- MBA students with a minimum of 2 years professional work experience.
- For non-native English speakers, an IELTS score of at least 6.5 is required for postgraduate students.

Accommodation

EBS do not provide on campus accommodation however the EBS Housing Office will assist students find suitable accommodation.

Credit information

EBS Universität uses the ECTS (European Credit Transfer System). A standard workload is 30 ECTS per semester. Credit for one UniSA 4.5 unit subject requires a minimum of 7.5 ECTS study.

Travel information

Australian students need a Visa and a German Residence Permit. The application process takes a minimum of 6-10 weeks.

Travel grant & scholarship information

Minimise your out of pocket travel expenses by applying for one of the University's international travel grants. If you are approved for one of our exchange programs you are eligible to apply. Each eligible student can receive up to \$2500 total in travel grants over their student life at UniSA.

Undergraduate students may apply for Australian Government OS-Help loans to assist with their expenses.

Insurances

UniSA provides exchange students with Travel Insurance for study related travel. It is mandatory for all students on exchange in Germany to take out health insurance through any German statutory health insurance company. Insurance for third-party liability is also recommended.
