About Essex

Colchester, home to one of the Essex Business School campus' is the oldest town in Britain and was once the capital of Roman Britain. It is located 80km northeast of London and is an hour away by train. Southend-on-Sea, commonly referred to as Southend, is a coastal town 70 minutes by train from London. It's home to the world's largest pier. It is also home to London Southend Airport making it an excellent base for exploring the UK and Europe.

What does it cost?

As an exchange partner with the University of South Australia, you do not have to pay fees at the Essex Business School as these are included as part of your fees at UniSA.

Travel and living expenses are at your own cost. The table below gives an indication of costs you will incur:

Return flights - Adelaide to London	\$1700
Return train and bus from London Heathrow Airport to Essex Business School (either campus)	\$60
Accommodation - single room, on-campus	\$136 - \$245 per week at Colchester campus \$233 - \$292 per week at Southend campus
Health insurance	\$120 per semester
Meals	\$300 - \$500 per month
Entertainment and incidentals including phone, laundry etc.	\$550 - \$600 per month

Key dates

Full semester exchange for undergraduate and postgraduate over three semesters with only two corresponding with UniSA Study Periods:

- Autumn Term: October December which corresponds with UniSA Study Period 5. Applications close on January 11.
- Summer Term: April June which corresponds with UniSA Study Period 2. Applications close on August 1.

How to apply

All exchanges are managed by the study overseas team at UniSA International who will help you apply for your exchange and will contact the partner institution on your behalf.

Entry requirements

- Undergraduate: A minimum of 36 units undertake at UniSA with a GPA of 4 or above
- Postgraduate: A minimum of 9 units at Masters level at UniSA with a GPA of 4 or above
- An overall IELTS score of 6.5 and no section below 5.5 or equivalent is required.

Accommodation

All full-time fully-registered undergraduate students studying at either the Colchester or Southend Campuses are entitled to

accommodation for the first year of study as long as they return their application by the deadline date. A range of other options are available within walking distance of campus. University accommodation is self-catering, with free internet access.

Credit information

Essex Business School has a standard workload of 3O units per semester, with each course receiving 7.5 units which is equivalent to one UniSA 4.5 unit subject. Applicants may undertake a 75% study load on exchange.

Travel information

Visas are not required for Australian Citizens if their stay is less than 6 months. All other nationalities should check with their travel agent and provide sufficient time to obtain their visa prior to travel as it can be a lengthy process.

Travel grant & scholarship information

Minimise your out of pocket travel expenses by applying for one of the University's international travel grants. If you are approved for one of our exchange programs you are eligible to apply. Each eligible student can receive up to \$2500 total in travel grants over their student life at UniSA. The UniSA Business School also provides Student Mobility Grants. Undergraduate students may apply for Australian Government OS-Help loans to assist with their expenses.

Insurances

UniSA provides exchange students with Travel Insurance for study related travel. Additionally, it is mandatory for all students on exchange to have private health insurance with full coverage for sickness, emergencies, repatriation sufficient to cover all medical expenses in the United Kingdom.
