SUMMER SCHOOL - DOING BUSINESS IN MEXICO

"Doing Business in Mexico" is a one-week program in March which participants have the opportunity to interact with colleagues from Mexico and other visiting countries while learning about Mexico as an emerging market. Mexico, along with countries like China and India, is an example of an emerging market. Generally, these countries have rapidly growing populations experiencing a substantial increase in living standards and income, rapid economic growth, and a relatively stable currency.

This summer school opportunity is also available to specialist Masters students in the second year of their program at UniSA.

What does it cost?

As an exchange partner with the University of South Australia, you do not have to pay tuition fees to IPADE as these are included as part of your fees at UniSA.

Travel and living expenses are at your own cost. The table below gives an indication of costs you will incur:

ITEM	COST
Return flights - Adelaide to Mexico	\$1700
Accommodation	\$250 to \$460 per month
Health insurance	\$140 per trimester
Meals	\$400 - \$800 per month
Entertainment and incidentals including phone, laundry etc.	\$400 - \$500 per month

Key dates

- Fall: October - December which corresponds with UniSA Study Period 5. The closing date for applications is January 11.
- Winter: January - April which corresponds with UniSA Study Period 2. The closing date for applications is August 1.
- Spring: April - June which corresponds with UniSA Study Period 2. The closing date for applications is August 1.

Entry requirements

- MBA students with a Bachelor's Degree in the second year of their MBA program and at least 2 years of work experience.
- Proficiency in English with a TOEFL Paper Version score of at least 600 points, or equivalent.

Accommodation

IPADE does not have on-campus housing, however assistance finding accommodation is provided through the international office.

Credit information

IPADE uses the IPADE Units Credit System. A standard workload is 8 IPADE Units per semester. Credit for one UniSA 4.5 unit subject requires a minimum of 2 IPADE units of study. Applicants may undertake a 75% study load on exchange.

Travel information

Students staying in Mexico for the duration of their exchange term can come in as a tourist and not apply for a Student Visa. If you are planning to stay longer, it is necessary to find out the requirements of the Mexican Consulate and we advise students to inquire about this before coming to Mexico.

Travel grant & scholarship information

Minimise your out of pocket travel expenses by applying for one of the University's international travel grants. If you are approved for one of our exchange programs you are eligible to apply. Each eligible student can receive up to \$2500 total in travel grants over their student life at UniSA.

The UniSA Business School also provides Student Mobility Grants. For more information, visit our website at i.unisa.edu.au/students/business/exchange/grants/

Undergraduate students may apply for Australian Government OS-Help loans to assist with their expenses.

Insurances

UniSA provides exchange students with Travel Insurance for study related travel. Additionally, students on exchange who do not have international health insurance coverage will have to purchase an insurance policy. IPADE will provide exchange students with the necessary information. It is mandatory for all students on exchange to have private health insurance with full coverage for sickness, emergencies, repatriation sufficient to cover all medical expenses in Mexico.
