## About Castellanza, Italy

Castellanza, Italy is a one hour drive from Milan, the global capital of fashion and design. Castellanza has a small population and, since the late 19th century, has been an industrial centre, home to 23,000 manufacturing and craft industries that export over 30% of their product worldwide.

The Alps provide a beautiful backdrop to the town and it is ideally situated near to the famous Italian lakes of Maggiore and Como and under a 2 hour flight to most places in Europe such as Paris, Athens. Barcelona and Munich.

## Why should I go on exchange?

By undertaking study overseas you gain a global perspective, increase your knowledge and develop new networks, enriching your life experience.

#### What does it cost?

As an exchange partner with the University of South Australia, you do not have to pay tuition fees to L'Universita Carlo Catteneo (LIUC) as these are included as part of your fees at UniSA.

Travel and living expenses are at your own cost. The table below gives an indication of costs you will incur:

ITEM	COST
Return flights - Adelaide to Milan	\$1300
Train from Milan to Castellanza	\$15
Accommodation - in a furnished apartment, including utilities and cleaning	\$900 per month
Health insurance	\$80 for 6 months
Meals	\$400 - \$700 per month
Transport	\$60 - \$70 per month
Entertainment and incidentals including phone, laundry etc.	\$400 - \$600 per month

#### **Key dates**

- Semester 1: September December which corresponds with UniSA Study Period 5. The closing date for applications is January 11.
- Semester 2: February June which corresponds with UniSA Study Period 2. The closing date for applications is August 1.

#### How to apply

All exchanges are managed by the study overseas team at UniSA International who will help you apply for your exchange and will contact the partner institution on your behalf.

#### **Entry requirements**

- Undergraduate: Completed 2 years of study with a GPA of 4 or above.
- Postgraduate: Must have a Bachelor degree in a relevant field. Completed 9 units in their UniSA masters program.
- For non-native English speakers, an IELTS score of at least 6 in English required.

#### Accommodation

On-campus accommodation is available in the 'Carlo Pomini' Halls of residence with 252 fully furnished and serviced rooms located on three floors.

#### **Credit information**

L'Universita Carlo Catteneo (LIUC) uses the ECTS (European Credit Transfer System). A standard workload is 30 ECTS per semester. Credit for one UniSA 4.5 unit subject requires a minimum of 7.5 ECTS study. Applicants may undertake a 75% study load on exchange.

#### **Travel information**

A Student Visa is needed for exchange students in Italy. Applications for your Student Visa needs confirmation of your enrolment by a Higher Education institution in Italy. You will also need to obtain a residents permit on arrival.

## Travel grant & scholarship information

Minimise your out of pocket travel expenses by applying for one of the University's international travel grants. If you are approved for one of our exchange programs you are eligible to apply. Each eligible student can receive up to \$2500 total in travel grants over their student life at UniSA.

Undergraduate students may apply for Australian Government OS-Help loans to assist with their expenses.

#### Insurances

UniSA provides exchange students with Travel Insurance for study related travel. Additionally, non-EU students are required to pay for appointments with a GP at the medical centre, which will cost \$45. It is mandatory for all students on exchange to have private health insurance with full coverage for sickness, emergencies, repatriation sufficient to cover all medical expenses in Italy.
