Vienna University of Economics and Business (WU) has received Triple Crown accreditation (EQUIS, AACSB, and AMBA) and is the only university in Austria to belong to this exclusive group of schools. WU's excellent international reputation is reflected in its student population: Roughly one in four students on campus has come to study at WU from abroad.

About Vienna

Vienna, the capital of Austria, lies in the country's east on the Danube River. Its artistic and intellectual legacy was shaped by residents including Mozart, Beethoven and Sigmund Freud.

The city is also known for its Imperial palaces, including Schönbrunn, the Habsburgs' summer residence. In the Museums Quartier district, historic and contemporary buildings display works by Egon Schiele, Gustav Klimt and other artists.

Vienna is around a 1.5 hour flight to London, Florence or Zurich making it an excellent base for travel within Europe.

Why should I go on exchange?

By undertaking study overseas you gain a global perspective, increase your knowledge and develop new networks, enriching your life experience.

What can I study?

SUMMER SCHOOL - INTERNATIONAL SUMMER UNIVERSITY

The International Summer University program consists of two courses taught over three weeks. You are able to choose from courses such as Human Resource Management, Marketing, Management, International Management, Social Media Marketing, Strategic Management, Financial Management, Sustainable Business, Global Marketing or International Marketing.

The successful completion of the undergraduate program is worth 8 ECTS and the postgraduate program is worth 9 ECTS.

What does it cost?

As an exchange partner with the University of South Australia, you do not have to pay tuition fees to Vienna University of Economics and Business as these are included as part of your fees at UniSA.

Travel and living expenses are at your own cost. The table below gives an indication of costs you will incur:

Accommodation	\$550 to \$630 per month
Health insurance	\$120 per semester
Meals	\$300 per month
Entertainment and incidentals including phone, laundry etc.	\$550 - \$600 per month

Key dates

- Spring Semester: March July which corresponds with UniSA Study Period 2. The closing date for applications is August 1.
- Winter Semester: September February which corresponds with UniSA Study Period 5. The closing date for applications is January 11.
- International Summer University: July August which corresponds with UniSA Winter School. The closing date for applications is January 11.

Entry requirements

 Undergraduate: A minimum of 36 units undertaken at UniSA with a GPA of 4 or above. A minimum internet-based TOEFL score of at least 95 points or equivalent (IELTS 6.5).

Accommodation

Credit information

Vienna University of Economics and Business uses the ECTS (European Credit Transfer System). A standard workload is 30 ECTS per semester. Credit for one UniSA 4.5 unit subject requires a minimum of 7.5 ECTS study. Applicants may undertake a 75% study load on exchange.

Travel information

Nationals of non-EU/EEA countries (so-called "third country nationals") need an Entry Visa or Residence Permit for entry into and residence in Austria. The type of permit depends on the length and purpose of the stay.

Travel grant & scholarship information

Minimise your out of pocket travel expenses by applying for one of University's international travel grants. If you are approved for one of our exchange programs you are eligible to apply. Each eligible student can receive up to \$2500 total in travel grants over their student life at UniSA.

Undergraduate students may apply for Australian Government OS-Help loans to assist with their expenses.

Insurances

UniSA provides exchange students with Travel Insurance for study related travel. Additionally, it is mandatory for all students on exchange to have private health insurance with full coverage for sickness, emergencies, repatriation sufficient to cover all medical expenses in Austria.
