Situated on the right bank of the Rhine, Vallendar, where WHU Campus Vallendar is located, lies at the heart of one of the most beautiful and ancient cultural landscapes, the Upper Middle Rhine Valley. It is approximately a 2 hour journey from Düsseldorf Airport to Vallendar by train.

#### What does it cost?

As an exchange partner with the University of South Australia, you do not have to pay tuition fees at the WHU, as these are included as part of your fees at UniSA.

Travel and living expenses are at your own cost. The table below gives an indication of costs you will incur:

Return flights - Adelaide to Berlin	\$1900
Return flight to Vallendar	\$350
Accommodation	\$480 to \$880 per month
Health insurance	\$120
Meals	\$300 per month
Bus pass for transport to campus	\$100 per month
Entertainment and incidentals including phone, laundry etc.	\$550 - \$600 per month

## **Key dates**

- Spring Semester: January May which corresponds with UniSA Study Period 2. The closing date for spring semester applications is August 1.
- Fall Semester: September December which corresponds with UniSA Study Period 5. The closing date for Fall Semester applications is January 11.
- Summer School: May June, with a closing date for applications of January 11.

All exchanges are managed by the study overseas team at UniSA International who will help you apply for your exchange and will contact the partner institution on your behalf.

#### **Entry requirements**

- A minimum of 36 units undertaken at UniSA with a GPA of 4 or above.
- An internet-based TOEFL score of at least 95 or equivalent is required.

# **Credit information**

The WHU - Otto Beisheim School of Management uses the ECTS (European Credit Transfer System). A standard workload is 3O ECTS per semester. Credit for one UniSA 4.5 unit subject requires a minimum of 7.5 ECTS study. Applicants may undertake a 75% study load on exchange.

## **Travel information**

Visas are not required for Australian Citizens however they must register for a Resident's Permit within 2 weeks of arrival. Check the WHU pre-departure information carefully for information relating to the documentation you will need. All other nationalities should check with their travel agent and provide sufficient time to obtain their visa prior to travel as it can be a lengthy process.

## Travel grant & scholarship information

Minimise your out of pocket travel expenses by applying for one of the University's international travel grants. If you are approved for one of our exchange programs you are eligible to apply. Each eligible student can receive up to \$2500 total in travel grants over their student life at UniSA.

UniSA provides exchange students with Travel Insurance for study related travel. Additionally, it is mandatory for all students on exchange to have private health insurance with full coverage for sickness, emergencies, repatriation sufficient to cover all medical expenses in Germany.
